At the WCA, it's the impact that counts. In 2024, we drove the economy forward while delivering meaningful results for our members. Through the contributions of our Board, working groups, members and staff, we advanced our vision to establish Westchester as a center of economic opportunity, growth, and upward mobility.

Our advocacy notched several important wins, from protecting millions in funding for hospitals and nursing homes, to advancing affordable housing and climate smart development, to sustaining one-of-a-kind projects to connect underserved communities to the digital economy.

We spearheaded initiatives that benefited the entire region through our best-in-class conferences and dedicated committees. We also hosted dozens of timely events, forging strong connections for thousands of members while showcasing the region's most important economic issues.

Additionally, hundreds of high-demand jobs were filled by local employers, hundreds more local households were connected to the digital economy, thousands of new housing starts were initiated, and tens of millions of dollars secured for our industries – all of this progress was supported through our influence.

As the WCA embarks on its 75th Anniversary, we are inspired by the legacy of leadership and innovation that brought us here. Together, we will continue to build a stronger, more vibrant and inclusive Westchester for all. Thank you for working with us and being a part of this success.



ADVOCACY >> We build alliances to advance economic vitality

The WCA sets the benchmark as the leading collaborative voice for the region's professionals in businesses, nonprofits, and higher education. While we advocate for general business interests, our approach is tailored each year to address economic priorities with the greatest impact. At WCA, we do not "cut and paste." Supported by our Public Policy Committee and industry-specific working groups, we build strategic alliances to deliver results.

In 2024, we advanced substantial progress in healthcare, talent development, digital connectivity, real estate, housing, and sustainability.





Securing a healthier future

Westchester's healthcare system is the bedrock on which the local economy is built. In 2024, WCA's advocacy ensured the sector's continued role as a regional leader. With healthcare contributing greater than \$13 billion annually to the region's economy and employing over 54,000 people, WCA's efforts have had far-reaching impacts, solidifying Westchester's position as a hub for world-class healthcare and economic opportunity.

WCA played a pivotal role in preventing over \$1 billion in Medicaid cuts and securing \$800 million needed by hospitals and nursing homes to sustain their operations and ensure access to world-class healthcare.

Recognizing a projected shortage of 65,000 healthcare workers in New York by 2028, WCA prioritized initiatives to help health providers expand training, retain talent, and promote innovative workforce solutions.

WCA's advocacy led directly to reducing administrative **burdens** for healthcare providers, including the elimination of COVID-19 sick pay mandates, so they could focus on delivering quality patient care.

ADVOCACY

Strengthening the regional talent pipeline

The demand for a skilled and adaptable workforce is more urgent than ever. In 2024, WCA actively worked to bridge the gap between education and employment, building pathways that benefit businesses, students, and the broader community.

Through our 1,000 Jobs Challenge, WCA led efforts to develop a robust talent ecosystem, spearheading a regional campaign to fill critical job vacancies across industries. By partnering with local employers, educational institutions, and workforce organizations, the Challenge addresses workforce shortages, connects residents to high-demand jobs, and drives measurable economic activity. To date, the program has filled over 200 local jobs and contributed over \$20 million in annual economic impact.

Key legislative victories for nurse simulation training will equip the next generation of healthcare workers with skills they need to succeed and accelerate the pipeline of talent in this area of critical need.

WCA advocated for strong collaboration between business and educational institutions to align curricula with industry demands. This resulted in impactful partnerships, such as Mercy University tailoring finance programs to meet employment needs for a regional accounting firm, and Long Island University Hudson creating a healthcare MBA to provide a talent pipeline for a large regional hospital.

WCA is a critical partner in how the county does economic and workforce development. Our priorities are the same: to ensure that Westchester has a workforce prepared to serve the needs of

employers and our communities.

Bridging the digital divide

Equitable access to technology is a necessity in a world that prioritizes digital acuity. Over 40,000 households in Westchester have no internet service. The WCA is changing that and transforming Westchester into a techforward, inclusive region where businesses and communities can thrive together.

WCA's advocacy secured over \$1.5 million in grants to advance digital inclusion, funding initiatives like Connect Westchester to provide underserved communities with high-speed internet, digital devices, and access to the new economy.

Working with our partners, we are advocating for affordable connectivity at the federal level while calling on Albany to streamline complex broadband permitting and regulatory barriers to ensure faster and more reliable internet access across the state.

We advocate for the expansion of programs such as the Statewide Digital Equity Plan to ensure broader access to technology. With WCA's input, these plans will include utilization outcomes, not just physical buildout.



Digital connectivity is not just about infrastructure; it's about creating opportunity. WCA's initiatives help underserved populations access workforce training, telehealth, and the digital economy, driving long-term economic growth and equity across the region.

ADVOCACY

Driving smart growth and housing action

Westchester's real estate market is central to its economic stability and quality of life. In 2024, the WCA's expanded efforts addressed the housing crisis, driving smart growth to meet the region's evolving needs.

Through our Real Estate Task Force, the central convening force for real estate stakeholders, we brought together municipal planners, developers, business leaders, higher education, nonprofits, and others to ensure that Westchester's real estate sector remained resilient and positioned for sustainable growth.

WCA's Welcome Home Westchester Coalition launched the "5 in 2025" local advocacy campaign, outlining five actionable steps municipalities can take to remove barriers, adopt housing solutions and support sustainable, affordable development. Partners include the Building & Realty Institute, Nonprofit Westchester, Regional Plan Association, Pace University Land Use Law Center, the Housing Action Council, Construction Industry Council, Westhab, Inc., and others.

We need to address housing affordability and smart development to attract talent and business to Westchester. The WCA finds ways to get to 'yes' — for economic opportunities and a high quality of life.

WCA empowered communities to embrace sustainable development through leadership on streamlining land use and zoning initiatives, addressing critical housing and climate challenges.



Setting the agenda: Dozens of conferences, thousands of professionals


WCA's best-in-class conferences remain a powerful showcase of thought leadership, each featuring top experts.

New York State Labor Commissioner Roberta Reardon delivered an inspiring keynote at our Workforce Summit, underscoring the importance of apprenticeships and upskilling, while sharing strategies and resources to navigate labor market challenges.

CONVERGE: The Hudson Valley Digital Innovation Conference showcased advancements in technology and digital equity, with Francella Ochillo, Director of Public **Engagement, National Telecommunications Information** Administration (NTIA), emphasizing digital connectivity's role in fostering economic inclusion.

WCA IN ACTION

Innovative programs with real-world impact

WCA delivered impactful programs during 2024 that addressed critical needs across an array of sectors, driving measurable results.

With Westchester County funding, WCA's Healthcare Talent Pipeline Program (HTPP) connected over 200 job seekers with healthcare careers, filling high-demand roles, generating \$18 million in economic impact and demonstrating a 16:1 return on investment.

The **Healthcare Career Launch Project**, led by WCA and funded by New York State, trained 50 job seekers for entry-level positions.

The Career Pathways initiative introduced students to diverse healthcare roles through panels with healthcare providers and high schools, paving the way for a strong talent pipeline and guiding young people toward fulfilling careers.

Regional career fairs, hosted in partnership with Westchester County, connected over 500 job and internship seekers with leading employers, helping to fill critical positions and strengthen Westchester's workforce pipeline.

Our Annual **World of Accounting and Finance** event connected professionals, educators and students to discuss career paths, networking and skill-building in a thriving industry.

Knowledge that drives growth

WCA delivered a wide variety of educational forums and training programs throughout the year, providing practical strategies to tackle issues and thrive.

An All Access Cyber Series addressed the rise in cyberattacks, emphasizing proactive measures to safeguard businesses from digital threats.

Our Affordable Housing Bootcamp, developed with our Welcome Home Westchester partners, equipped newly-elected municipal officials with knowledge and resources to address housing shortages, with discussions on creative solutions like repurposing vacant office spaces for multifamily housing.

Our Westchester Municipal Climate Education
Project, held in partnership with the Pace Land
Use Law Center, was a first-of-its kind training
program to arm municipal leaders with tools to
integrate climate action and resiliency into zoning
and land-use policies, fostering sustainable growth.

We launched our updated Clean Energy Portal, created in partnership with Pace University, with dozens of new resources and incentives to help businesses transition to a low-carbon future.
